Establishment of the Maharashtra
State Hindi Sahitya Academy.

RESOLUTION: - Government is pleased to establish the State Hindi Sahitya Academy for promotion and encouragement of Hindi literature in all its aspects in the State. The Board of the Academy will consist of the following :-

2. The tenure of the Board of this Academy will be three years

The Academy shall start functioning from the date the Chairman assumes office.

The functions of the Academy shall be :-

- i) To encourage the Hindi Language in all its aspects in this State.
- ii) To promote exchange of creative ideas between the State Language Marathi and Hindi through translation and other literary pursuits.
- iii) To initiate, assist or undertake the implementation of projects or schemes which may further the cause of Hindi.

- iv) To initiate, assist or undertake the publication of papers, monographs, books and journals in Hindi.
- v) To provide financial assistance to writers and poets, resident in Maharashtra for publication of their literary works if approved by the Board.
- vi) To provide financial assistance to Hindi literary societies and Hindi literary activities.
- vii) To initiate, assist or organise seminars, conferences, symposia or exhibitions for the encouragement of Hindi in the State.
- viii) To supply books or magazines to the libraries and Public reading rooms.
- ix) To give awards for excellence in Hindi in different literary fields to writers and poets resident in the State.
- x) To ^{give} fellowship and/or Scholarship to deserving Hindi scholars or students resident in the State.
- xi) To raise resources, funds, donations and/or contributions from the public by such means as may be approved by the State Government and to utilise the same for the activities of the said Academy.
- xii) To keep the State Government informed from time to time of activities of the Board.
- xiii) To advise Government in formulating its policies in the matter of development of Hindi in the State and in assisting in their implementation.

For attending the meetings of the Academy, the Members (other than non-official members) shall be held eligible to draw T.A. and D.A. at the rates admissible to them according to the rules applicable to them under Government, University or any other official body under which they are working. The non-official members of the Academy shall be held eligible to draw travelling allowance and daily allowance at the rates admissible under scale I of rule I(1)(b) of Section I in Appendix XLII-A to the Bombay Civil Services Rules, Volume II, read with Government Resolution Finance Department No. TRA-1477/1032-C/SER-5, dated 23-09-1977. The T.A. and D.A. of the Chairman of the Academy shall be regulated as per the Government Resolution, Finance Department No. TRA-1470/131/XVIII, dated the 27-1-1971. The Under Secretary to Government of Maharashtra, General Administration Department is authorised to countersign the travelling allowance bills of the non-official members of the Academy.

4. The orders as to the manner of booking the expenditure on account of the Board of the Academy will be separately issued shortly.

5. This Government Resolution issues with the concurrence of the Finance Department vide its un-official reference No. 708/EXP-4/82, dated the 9th March, 1982.
